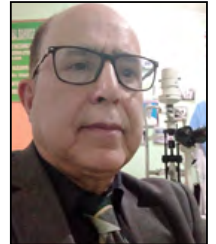


## Squint types causes management and role of parents in mobile data abuse by children

### Abstract

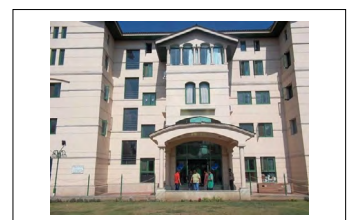
Squint also commonly termed as strabismus is a kind of common ocular condition chartered by abnormal ocular devotion with absence of normal ocular paradigm and paucity of binocular vision which is of 3 types Simultaneous perception, simultaneous fusion and stereo psis.

Main aim of squint management is not only to correct abnormal ocular devotion but to ensure normal status of vision for this early diagnosis and management by proper squint expert is very important so it is very important for every parent to seek the advice of pediatric ophthalmologist if they observe any sort of abnormal ocular devotion in past in underdeveloped Asian countries squint was considered to be a kind of stigma especially in females so proper management was not done by the time management was sought squinting eye was in the phase of amblyopia which is commonly termed as. Lacy eye with better' awareness and education and recent advances in ophthalmology the prognosis of squint is far better than before one of the basic criteria for assessment of daunt management is visual assessment mydriatic refraction and fundus examination there are few ocular conditions which cause squint like retinoblastoma and Coates disease. Squint can be accommodative non accommodative commitment or in-commitment, paralytic or non-paralytic squint. Squint can be exotropia esotropia, hypertropia, hypotropia, heterophoria pseudo squint microtropia, cyclophoria, orthophoria microtropia paralytic squint can present as dimension of vision impairment of ocular movements diplopia primary devotion is greater than secondary deviation turning the heard towards the direction of action of paralyzed muscle false orientation false projection abnormal head tilt ocular torticollis vertigo.

Mobile data abuse by children manifestations are headache eye ache, eye strain irritability, change in behavior of child fainting, abdominal pain, nausea, delayed mile stones even epileptic like attacks blued vision squint diplopia.
